Jeff Hedrick, having appeared before the undersigned notary and first been duly sworn, deposes and says:

- 1. I am an attorney duly admitted to the practice of law in North Carolina.
- 2. I practice law in Boone, NC.
- 3. I represented Robert Charles Bragg, along with Vincent Gable, and was Bragg's attorney during his trial in Watauga County, NC on February 5 through February 26, 1996.
- 4. Approximately four (4) years ago, I was contacted by someone, apparently not the North Carolina Innocence Inquiry Commission, regarding my file for this case. I conducted a search at that time. This search included the following locations: my office and my off-site storage location on property I own. I was unable to locate my file.
 - 5. I have a few files going back to 1986.
- 6. On May 5, 2016, I was deposed by Catherine Matoian of the North Carolina Innocence Inquiry.
- 7. During the deposition, I was asked about my file. After the deposition, at the request of the Commission, I agreed to conduct an additional search for my file in this case.
- 8. On or about 26 May and twice thereafter, I searched the above locations for my file in this case. I was unable to locate my file which had been in bankers' boxes, labeled with Mr. Bragg's name, except I did locate in my office a draft of my Court of Appeals brief for Bragg with my note that it should be put in Bragg's file in my off-site storage location.
- 9. I have retained files, sometimes indefinitely, but due to lack of storage, I began over five (5) years ago to destroy older files using a shredding service, on-site, for my older, especially larger files, to make space. Within the past six (6) years, I began

scanning my new files in order to preserve them and allow more space for retained paper files.

- 10. There are no additional locations where my file for this case may be located.
- 11. I have also contacted Private Investigator Jerry Vaughn, who worked on this case, about my file. He did not provide any information that was helpful in locating my file.
- 12. Mr. Bragg always maintained that he was innocent of this crime during my representation.

- 1. I am an inactive attorney who was previously admitted to the practice of law in North Carolina.
- 2. I practiced law in Boone, NC from (YEARS). 1989-2007
- 3. I represented Robert Charles Bragg, along with Jeff Hedrick, in the above captioned case and was his attorney during his trial in Watauga County, NC on February 5 through February 26, 1996.
- 4. On June 20, 2016, I was contacted by Catherine Matoian, Grant Staff Attorney for the North Carolina Innocence Inquiry Commission regarding my representation of Mr. Bragg. Ms. Matoian provided me with a copy of Mr. Bragg's rights waiver.
- 5. My recollection is that approximately (NUMBER) years ago, I was contacted by an agency regarding my file for this case. Because my representation of Mr. Bragg was completed at that time, I sent my file to those individuals. (IF YOU CAN REMEMBER ANY ADDITIONAL DETAILS REGARDING WHO REQUESTED THE FILE/WHO YOU SENT THE FILE TO, PLEASE ENTER THEM HERE).
- I no longer have any files related to my law practice.
- 7. There are no additional locations where my file for this case may be located.
- 8. Mr. Bragg always maintained that he was innocent of this crime during my representation.

9. Prior to the above captioned case, I represented Mr. Bragg on other misdemeanor offenses. Mr. Bragg would admit guilt in some of those offenses.

Kristin Parks, having appeared before the undersigned notary and first been duly sworn, deposes and says:

- 1. I am an attorney duly admitted to the practice of law in North Carolina.
- 2. I practice law in Chapel Hill, NC.
- 3. I was an attorney with North Carolina Prisoner Legal Services (PLS) from 1995 until 2003. During that time, I was assigned the case of Robert Charles Bragg. I was assigned this case, along with other attorneys, as I was on two extended maternity leaves during my employment at PLS.
- 4. When I left PLS I started my own law practice doing capital defense litigation.
- 5. After I left PLS, in the fall of 2003, I continued to work on Mr. Bragg's case.
- 6. I was contacted by the North Carolina Innocence Inquiry Commission (Commission), regarding my file for this case. I believe that I previously provided materials from the file to the North Carolina Center on Actual Innocence (Center) when I referred the case to them in 2006.
- 7. I do not recall the exact details of my referral of the case to the Center, but I remember that I was looking for someone who could handle an innocence claim, since I was unable to work on the case in private practice. I asked Richard Rosen for advice, and that is how I found out about the Center.
- 8. I do not remember taking the original PLS file with me when I left PLS in the fall of 2003.
- 9. My recollection is that I was contacted by the Commission in 2011 and asked to provide any documents that I had in my possession related to the case. This

was limited to some letters with Mr. Bragg, appellate briefs, notes and documents I obtained from Mr. Bragg's attorney.

- 10. As far as my specific recollections from the case, I recall:
 - a. Contacting the Watauga Clerk of Court to determine if any evidence was still retained in the case. I was told that the evidence had been destroyed.
 - b. Attempting on several occasions to contact Jeffrey Nelson. I recall that Mr. Nelson was a young boy who testified to seeing Mr. Bragg and Kenneth Coffey following the victim. I can recall going to a residence that I believed Mr. Nelson resided at and a family member trying to discourage contact and keep me away from Mr. Nelson. I recall similar attempts such as this when I tried to contact Mr. Nelson on previous occasions.
 - c. Speaking with one of the lawyers who told me the trial judge that presided over Mr. Bragg's trial worried that the jury convicted Mr. Bragg because Mr. Bragg was homeless and prison would give him a place to sleep and 3 meals a day.
 - d. Hiring a private investigator in the case who attempted to locate physical evidence with the Clerk but was told the same information as I was about the evidence having been destroyed. The investigator's name was Jerry Vaughn. Mr. Vaughn also attempted to locate Jeffrey Nelson. I believe Mr. Vaughn was upset because PLS had not paid him for some of his services in the case.
 - e. I recall knowing about a Crimestoppers reward that was received by Jeffrey Nelson or his mother, Rene Nelson but I do not recall how I know this information. Prior to the Crimestoppers reward, Rene Nelson had an entirely different story about what happened.
- 11. I often bring up this case when speaking with colleagues. I have practiced criminal law for over twenty years and there are very few cases where I believe in a client's innocence, but from all that I have learned about this case and about Mr. Bragg, I believe in Mr. Bragg's innocence.
- 12. Over the years, I have continued to stay in touch with Mr. Bragg by writing letters and sending Christmas cards. I do this with several former clients. I know Mr. Bragg does not have family to help him.
- 13. Mr. Bragg always and consistently maintained he was innocent of this crime during my representation and in the years since.

- 6. To my knowledge, the file may be with my former employer North Carolina Prisoner Legal Services or Kris Parks.

- 1. I am an inactive attorney who was previously admitted to the practice of law in North Carolina.
- 2. In 1994 through 1996, I was an Assistant District Attorney in the 24th Judicial District.
- 3. I was the lead prosecutor in State v. Robert Charles Bragg tried in Watauga County, NC on February 5 through February 26, 1996.
- 4. On May 31, 2016, Catherine Matoian of the North Carolina Innocence Inquiry contacted me regarding my recollection of Crimestoppers tips in this case.
- 5. My recollection is that a confidential informant in the Robert Charles Bragg case called in an anonymous tip to Crimestoppers stating that she had seen Robert Charles Bragg at the home of the victim, Marvin Coy Hartley, on the day of the murder and that her young son had seen Robert Charles Bragg leaving the home of the victim, Marvin Coy Hartley, on the day of the murder.
 - 6. This witness agreed to testify and at that point was no longer anonymous.
- 7. Ms. Matoian told me that the witness's name is Rene Nelson and her son's name is Jeffrey Nelson, but it has been a long time and I do not remember their names.
- 8. Jim Harrison, the lead investigator in this case for the Boone Police Department, told me after the trial that this witness would receive a reward through Crimestoppers.
- 9. The district attorney file for this case would not contain any information regarding or record of Crimestoppers rewards given out.

December 8th, Gray stated that she had left work at K-Mart and drove home and the time was around 5:10 PM and when she got out of her car, she saw Coy Hartley going up the steps to his trailer and she said he had on his green jacket and jeans and he was carrying his walking stick or maybe something with a brown handle. Cherie went home for lunch at 12:00 and she said she saw Coy walking up Winter Street toward his trailer and she waved at him and he waved back at her. Cherie states that she didn't see anything by apparently David Doss and Nancy Horton may have seen something. Cherie said that there is alot of foot traffic in and out of the trailer park and about three weeks ago, she had her car speakers stolen out of her car.

Cherie mentioned that Nancy Horton had seen a tall guy with dark bushy hair and cap walking up towards Coy's trailer and that was when Nancy was leaving to go pick up a neighbors child from day care and the time was around 4:45 PM.

Cherie said that she left home between 6:20 and 6:30 PM to take her daughter to the skating rink and she recalls seeing lights in Coy's trailer and the lights looked pretty bright and she saw a couple of guys walking in and out of the trailer park and one of them had dirty blond hair with a leather jacket with things hanging off of it and she recalls seeing this guy walking by himself.

Cherie mentioned that a Mr. Hughes came over to Coy's trailer and they were good friends and Mr. Hughes would check in on Coy and he drives a white Berretta. Cherie hasn't noticed as much traffic in and out of Coy's lately. I asked Cherie if she had ever noticed Coy carrying a billfold and she thinks she had noticed maybe one like a biker carries with a chain, but not sure. She mentioned that Coy was having water problems sometime back and Coy came over and got some water from her. She further advised that she thinks that coy carried his billfold on his left side.

December 19, 1994 at 11:10 Am, Det. Shook and myself rode back over to Winter Street and we spoke with Cherie Gray again. I asked her again about the time that she came home and she states that she's pretty

sure that she left K-Mart at 5:05 PM and Coy was on his steps with his stick as she pulled up.

Cherie said that she had seen the Watauga Democrat and the guy, Bragg, she had seen him going to Coy's trailer every few days. I asked Cherie if she knew Kenneth Coffey and she said that she did and she has seen him going to Coy's also.

Upon contacting Cherie Gray, I advised her that at the District Attorney's request, that I needed to clarify part of the statement that she gave concerning seeing two people in the trailer park between 6:20 and 6:30 PM.

Cherie stated that she was getting ready to take her daughter to the skating rink and she had looked out of her kitchen window and saw a white male with collar-length blonde hair, maybe 5'10", not heavy, walking down the street toward the highway. She said that he had on a black leather jacket with chains and "do-dads" hanging off of it and that was the only thing that really caught her attention and he may have had blue jeans on. Cherie states that she can't really remember anything about the other person, but both guys were walking down the street, but they were not walking together. Cherie states that she was gone maybe five minutes and she returned home.



It is difficult, but not impossible to correct.

Over the years, I've interviewed many young people who have said things that may not be true. Children are often afraid their parents will get in trouble if they come forward. I think that you and your mother may be afraid of what will happen if you come forward with the truth. I'm only interested in proving Mr. Bragg is innocent of the murder he was wrongly convicted of. I ask you to remember that he is serving a life sentence for a murder he did not commit.

Again, I'm begging you. If you have any information that might help me to help Mr. Bragg, please contact me. The address and phone numbers are listed above. I do wish you the best, Jeffrey, and know in my heart that if you will tell the truth, it will help you too.

The undersigned, having first been duly sworn, deposes and says the following:

- 1. I am over the age of eighteen, suffer no legal disabilities, have personal knowledge of the facts set forth below, and am competent to testify.
- 2. I am employed as an Evidence Technician at the Boone Police Department (BPD).
- 3. The evidence facility consists of two secured rooms with restricted access. The doors remain locked and are in the interior of the secured police department. There are specific areas for certain types of evidence. Evidence is logged by computer to track the chain of custody and its location within the assigned evidence room.
 - The evidence facility has not relocated since 1994
- 5. On or about February 15, 2011, Evidence Technician April Gunter, under the direction of Captain Andy Le Beau, physically searched for evidence related to Robert Charles Bragg, Kenneth Eugene Coffey, and Marvin Coy Hartley at the request of the North Carolina Innocence Inquiry Commission (NCIIC). On 9/28/2011, April Gunter and Andy Le Beau provided all evidence to Sharon Stellato of NCIIC. We were contacted again on 5/6/2014 by Jasman Walson at NCIIC to conduct a second search for additional evidence related to this case. We searched the evidence room and the evidence logs. No additional evidence was located as a result of that search, aside from photographs, and no other evidence remains in the possession of BPD.
- 6. I also searched for documentation of destruction related to Robert Charles Bragg and Kenneth Coffey and did not find any such documentation.
 - The oldest piece of evidence retained by our facility is from 1987.
- 8. Once evidence is submitted to the evidence technician at BPD, it is entered into the department's computer system for inventory and chain of custody purposes. The evidence technician then assigns the evidence a location, which is documented within the computer system, and the evidence is then placed in that secured location by the evidence technician. In 1994, prior to common use of computers in this

process, the evidence storage system was accomplished by using evidence log books to document the same information.

- 9. Evidence is securely packaged upon submission and labeled with numerous descriptors to include pertinent information for tracking purposes to generally include but not limited to: defendant(s) name, officer name, date and time collected, location collected, from who the evidence was collected (if known), and importantly an OCA number. This OCA number is a unique identifying number assigned to each specific case. Some of the descriptors have likely changed over the years as there have been numerous changes in administration and at least three previous evidence technicians since 1994, but the process would be similar and the OCA numbering system would be the same.
- 10. BPD has no record of receiving evidence back from the Watauga County Clerk's Office in 2005. The Watauga County Clerk of Court's Office would not have sent evidence back to BPD for destruction in 2005.
- 11. BPD conducts regular audits and inventories of our evidence facility as directed by the Chief of Police. Our last audit/inventory was conducted in 2014 by Evidence Technician April Gunter. At that time, there were no discrepancies.
- 12. There are not any unlabeled items of evidence or evidence that is not associated with a BPD case in the evidence facility.
- 13. All areas where evidence is retained have been searched for evidence related to this case.

The undersigned, having first been duly sworn, deposes and says the following:

- 1. I am over the age of eighteen, suffer no legal disabilities, have personal knowledge of the facts set forth below unless stated upon information and belief, and am competent to testify. As to those facts stated upon information and belief, I believe them to be true.
- 2. I am employed as a Captain at the Watauga County Sheriff's Office (WCSO). I have been a sworn officer with the Watauga County Sheriff's Office since 2001. I have held the rank of Captain since 2006. Upon my promotion to this position, part of my duties include the supervision of the Watauga County Sheriff's Department evidence room.
- 3. The Watauga County Sheriff's Department evidence room is located at the Watauga County Law Enforcement Center. The Evidence Room is a large two-room secure area of the Law Enforcement Center, with rooms approximately 24' x 30' and 24' x 10'. The area is secured by double locks and is only accessible by an authorized and trained evidence custodian. All evidence received and removed from the Evidence Room is logged according to property control number and status. This procedure has been used continuously since 2006 when I became Captain of Investigations.

The Watauga County Sheriff's also utilizes a secure area in a building adjoining the Law Enforcement Center. This area is also secured by double locks and is only accessible by an authorized and trained evidence custodian. The process for receiving and removing evidence from this area is the same as described above.

- 4. The evidence facility has relocated one time since 1994. All evidence in the custody of the Watauga County Sheriff's Department was transferred to this facility at 184 Hodges Gap Road in Boone, North Carolina when the Sheriff's Department relocated from its long-standing location at 330 Queen Street, Boone, North Carolina.
- 5. Upon information and belief, the Watauga County Sheriff's Department has not held any evidence for the Town of Boone Police Department since approximately 1989. Since my employment with the Watauga County Sheriff's Department in 2001, I am unaware of the Watauga County Sheriff's Department storing evidence relating to any homicides or cases exclusively investigated by the Town of Boone Police Department.

The Watauga County Sheriff's Office does store evidence for the North Carolina Division of Community Corrections, the North Carolina State Bureau of Investigation and occasionally for other state and federal agencies.

- 6. At the request of Catherine Matoian of the North Carolina Innocence Inquiry Commission, I have searched for whether evidence related to this case is in the possession of the Watauga County Sheriff's Office. Most recently, on or about May 11, 2015, I physically searched for evidence related to Robert Charles Bragg, Kenneth Eugene Coffey, and Marvin Coy Hartley at the request of the North Carolina Innocence Inquiry Commission (NCIIC) and I did not find any evidence related to this case. As part of my search, I searched written and electronic records pertaining to items stored as evidence at the Watauga County Sheriff's Office, including a search of the names of all three individuals.
- 7. I also searched for documentation of destruction related to Robert Charles Bragg, Kenneth Eugene Coffey, and Marvin Coy Hartley and did not find any such documentation. In searching for documentation of destruction, I searched the names of the above stated individuals. Since I did not have a property control number for any particular piece of evidence, I could not search by property control number. I also reviewed paper documents from prior years records.
- 8. Upon information and belief, the oldest piece of evidence retained by our facility is from 1972.
- 9. Upon information and belief, the Watauga County Sheriff's Department has logged evidence by an evidence control number, suspect name, owner, officer presenting evidence for custody, and Sheriff's Office case number since at least the early 1970's. Since 2000, the Watauga County Sheriff's Department has used Sheriff's Pak for its electronic tracking of evidence.
- 10. For items with multiple co-defendants, each co-defendant's name is entered into the system under that custody control number.
- 11. For cases where an arrest is made or Court proceedings are pending, completed, or contemplated, the Watauga County Sheriff's Department does not destroy any evidence unless it has approved for destruction by the District Attorney's Office and a District or Superior Court Judge.
- 12. Upon information and belief, since 2006 I have only received destruction orders from the Watauga County Clerk of Superior Court on two separate occasions. When I receive these Orders, I meet the Assistant Clerk and acknowledge receipt of the Order and evidence to be destroyed. Upon signing the appropriate documentation, the evidence is transported to the Watauga County Sheriff's Office for destruction. The destruction of the evidence is then logged and witnessed by at least two officers. Upon information and belief, when we have received destructions Orders from the Watauga

County Clerk of Superior Court, it has only been for cases where the Watauga County Sheriff's Department has been the charging agency.

- 13. I am not aware of a bulk amount of evidence being received from the Watauga County Clerk's Office for destruction in 2005.
- 14. I have not seen the documentation from the Watauga County Clerk's Office related to the evidence in this case.
- 15. WCSO conducts regular audits and inventories of our evidence facility at least once a year. Our audits are ongoing and conducted by spot check of randomly selected pieces of evidence. Since 2006, these audits have only revealed minor discrepancies.
- 16. There are not unlabeled items of evidence or evidence that is not associated with a case in the evidence facility.
- 17. All areas where evidence is retained have been searched for evidence related to this case.

It is **Ordered** this order shall be filed with permanent records of this case and with the file entitled State of North Carolina vs. Kenneth Eugene Coffey file number 95 CRS 121. Further the Court directs a duplicate original be given to Kenneth Eugene Coffey.

The Court determines that the provisions of North Carolina General Statutes section 15A-1051 are applicable and orders Kenneth Eugene Coffey to testify. In the event said Kenneth Eugene Coffey asserts his privilege against self incrimination, this court will order him to testify.

To: Kenneth Eugene Coffey, you will not be excused from testifying on the ground that your testimony may tend to incriminate you. Your testimony may not be used against you directly nor may any information indirectly derived from your testimony be used against you in a criminal case.

Dear Bill:

On February 5, 1996, I telephoned you and apprised you that I was applying for use immunity for Kenneth Eugene Coffey. At that time I related the circumstances of the case. You requested that I put the matter in writing.

Kenneth Eugene Coffey was convicted on December 1, 1995, of the first degree murder of Marvin Hartley. His conviction is on appeal. Mr. Hartley had been bludgeoned to death in his home. Cause of death was multiple lacerations on his head caused by a blunt instrument. Early on Kenneth Eugene Coffey became a suspect and was often interviewed by law enforcement. Although his statements were not all consistent, he did maintain that Robert Charles Bragg killed Hartley. Coffey's statements gave indication that he was at least present during the homicide. His statements were received in evidence at his trial and together with other circumstances became the basis for his conviction.

Without testimony of Coffey the district attorney perceived there to be little chance of conviction of Robert Charles Bragg. The trial of Robert Charles Bragg began on February 5, 1996, and a jury was impaneled in a capital trial. On February 8, 1996, I gave notice to the court and to counsel for Bragg that we were prepared to apply for an order requiring Coffey to testify. The court appointed an attorney for Coffey. On February 14, 1996, Coffey was called to the stand and he invoked his privilege against self incrimination. The judge ordered him to testify pursuant to our application.

Enclosed are (1) my application for an order, (2) notice given counsel for Bragg, and (3) the order of the court.

That on 13 February 1996 I met very briefly with Gail Fannon, attorney for Kenneth Eugene Coffey on two occasions. At the initial meeting Ms. Fannon asked, assuming Mr. Coffey provided truthful testimony, if the original plea offer would again be forthcoming if Mr. Coffey's conviction were overturned on appeal, what willingness our office would have to recommend to the Governor some reduction in Mr. Coffey's sentence and what protection Mr. Coffey could receive in prison. I told her that I would not be personally opposed to any of those things but I would have to consult with the District Attorney and give thought to her requests before making any promises to her or Mr. Coffey. At the outset of the second meeting I told Ms. Fannon that the State could not promise her or Mr. Coffey anything. That the things we earlier discussed were, from our standpoint, reasonable but that we could not make any promises to her or Mr. Coffey concerning them or any other help he might request. explained to her the Protective Custody program in the Department of Correction and told her the same thing I have always told defendants and attorneys in similar situations: If he testifies truthfully I would feel he deserved some help but that I could not make any promises as to what that help might be; if he did not he would foreclose any expectation of help he may have.

I represented Kenneth for purposes of his testimony in the Bragg case. I was not his attorney in the trial of his own case. Prior to and in connection with his own case he had made several statements. The one which law enforcement found believable was one that was made to the polygraph operator, a session that Kenneth went to without his attorney, after one was appointed for him. When he was brought back and requested to testify following his conviction, I was appointed and went to jail in an adjoining county (Bragg was in jail here) to interview him, at which time he agreed to testify. His conviction was on appeal and the options I discussed with the district attorney were 1) that if his appeal was granted we would have a plea offer of second degree, 15 years, 2) that if he was not successful on his appeal, the state would "not object" (my wording for lack of a better term) to application to the appropriate body - Court, governor, for a reasonable reduction in his sentence. The district attorney did not promise anything. It is not policy for him to do so prior to testimony of a witness but the assistant that we dealt with can be depended on to follow through.

Kenneth did testify at the Bragg trial in such a manner that the district attorney and law enforcement were quite pleased. After previously having given different versions, his story from the start appeared to be the most truthful and was well delivered by Kenneth, along with his maintaining himself well during cross examination. Bragg was convicted.

Then for some unknown reason the attached letter was sent to the Judge or district attorney, I'm not sure who first received it, by Kenneth or on his behalf. I don't know whatever possessed him to write it but I do suppose Gragg's attorney will use it as the basis for a Motion as Gragg's conviction and sentencing were upheld on appeal last week.

I have contacted the district attorney after receiving your letter and inquired (with hat in hand) whether he would oppose a "reasonable" motion for appropriate relief. The answer was

non-committal but favorable. I think that he will certainly still discuss the options, but we would all like to know why he wrote the letter.

Please contact me if I can be of further assistance, especially in speaking with the district attorney and discussing a plan of action that would not receive opposition.

Affidavit of Kenneth Eugene Coffey

Now comes Kenneth Eugene Coffey, and being first duly sworn, deposes and says

- 1. I am currently a resident of Avery County, North Carolina, where I am now incarcerated at Avery/Mitchell Correctional Institution located at Spruce Pine, North Carolina. I am more than 18 years of age. I make this affidavit based on my own personal knowledge.
- 2. That on or about sometime in November of 1996, while incarcerated at Marion Correctional Institution, located at Marion, North Carolina, two inmates known as Wallace Jones and Jimmy Macrey came into my cell. Once inside inmate Jones pulled out what appeared to be a hand made knife. Both Jones and Macrey then explained that they were going to kill me if I did not write a letter to the District Attorney exonerating my co-defendant, Robert Charles Bragg, whom I testified against at trial.
- 3. As a result of the serious nature of the threat I wrote the letter to the District Attorney exonerating my co-defendant. The letter stated in part that I did not see Bragg do any of the beating and that I lied during my testimony at trial. However, the letter was made under threat and duress, and therefore the letter wrote to the District Attorney was false.
- 4. It is my testimony at trial that is truthful in my case. After being threatened I told inmates Jones and Macrey to write the letter and that I would sign it, however, they refused because they wanted the letter to be in my own handwriting.
 - 5. After watching me mail the letter, inmates Jones and Macrey then left me alone.
- 6. I later learned that inmate Wallace Jones was serving a sentence of Life plus 40, and inmate Jimmy Macrey was serving a sentence of 90 years, and both were good friends of Robert Charles Bragg, my co-defendant.
- 7. While at Avery/Mitchell Correctional Institution I recently met an immate by the name of Richie Sanborn who explained to me that he had been stabbed by Jimmy Mackrey and Aaron Outlaw sometime in early 1995 because they wanted him to write a statement incriminating himself in a crime that some else had committed and he refused.

Hartley, a native of Watauga County whose funeral was Tuesday, had been found last Thursday night in the living room of his trailer at 181 Winter Drive in the Greenway Trailer Park in

Boone An autopsy, revealed that Hartley had died after suffering blunt head trauma, as well as bleeding around the brain, caused by a beating he sustained. He also had cuts and bruises on his head and chest, said Dr. Brent Hall, who handled the autopsy.
